



## WAGMORE POLICIES

This agreement includes a release of liability and waiver of legal rights and deprives you of the right to sue the owner(s) of any Wagmore or related properties. Do not sign this agreement unless you have read and understand it in its entirety. Seek the advice of legal counsel if you are unsure of its effect.

In consideration for your dog(s) ("Dog") being permitted to come to Wagmore's facility or to be cared for by Wagmore in your home, you agree to all of the policies, procedures, releaser, terms and conditions set forth below. The following Agreement will apply at the Wagmore facility in Stamford, CT, and will be referred to as "WM".

### All Dogs must:

- Be current on Rabies Distemper, Parvo and Bordetella vaccinations
- Be at least 4 months of age
- Be spayed or neutered if 6 months of age or older
- Be in general good health and free of ticks and fleas
- Be non-aggressive towards other dogs and people
- Not be protective of toys
- Complete the Wagmore interview process to Wagmore's satisfaction
- Meet all state licensure and other requirements
- Have a quick release collar that contains an identification tag bearing the Dog's name and owner's current contact information
- Be leashed when entering and exiting Wagmore

**Food.** Daycare Dogs will be fed in accordance with the instructions provided by the owner. While at Wagmore Daycare dogs do not get fed a mid-day meal. If you would like your dog to eat a mid-day meal, you must provide Wagmore with a container marked with your Dog's name and feeding instructions.

**Photos.** Photos may be taken at Wagmore for use in marketing materials. By using Wagmore's facility you agree to allow Wagmore to use your dog's name and any image or likeness of your dog taken while at Wagmore. Images may be used for marketing or promotional materials.

**Personal property.** Wagmore will not be liable for any lost, stolen or damaged personal property belonging either to you or to your dog. If your dog causes any

personal property damage to Wagmore, you will be responsible for the full cost of all treatment, repairs and replacements.

Fees. You must pay for all services and products by credit card, cash or check. All payment is due at the time that you pick your dog up. You give your express permission for Wagmore to charge any credit card you provided for unpaid services or products upon the date services were supposed to have been completed. You further agree to pay any collections costs and the cost of any returned or challenged check or debit charges.

Cancellation or Refund policy. You will be charged the equivalent of one full day of doggy day care if you fail to cancel a reservation for doggy day care twenty four hours in advance of drop off time. You will be charged one full day of boarding if you fail to cancel your boarding reservation at least forty eight hours in advance of drop off time. Notwithstanding the above, if your boarding reservation is within three days of the a nationally recognized holiday, you must cancel your reservation within seventy two hours or you will be charged a no-show fee equal to two nights of boarding.

Aggressive Dogs. If your dog exhibits aggressive or other unacceptable behaviors he may be separated from other dogs or asked not to return to Wagmore. This decision will be made solely by Wagmore.

Abandoned Dogs. No dog may be left at Wagmore after the scheduled pick up time without communication from you. If your dog is left at Wagmore without any contact, instruction or notification regarding its pick up from you or your authorized representative, your dog will be deemed "Abandoned" seven days after the scheduled pick-up time. If you abandon your dog at Wagmore, Wagmore will become the legal owner and guardian. Wagmore will determine the best course of action for the dog, whether to rehome him or relinquish it to a shelter. IF YOU ABANDON YOUR DOG AT WAGMORE, YOU UNDERSTAND THAT YOU MAY BE UNABLE TO RETRIEVE POSSESSION OF YOUR DOG AND WILL HAVE NO RECOURSE AGAINST WAGMORE.

Duty to disclose. You must disclose on a continuing basis any and all medical or other conditions, including but not limited to personality concerns or behavioral incidents that may affect, limit or prevent your dog's ability to participate in activities or stay at Wagmore.

ACCEPTANCE AND ACKNOWLEDGEMENT OF RISK. YOU FULLY UNDERSTAND THAT: (A) THERE IS INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS. AS WELL AS BETWEEN DOGS AND OTHER DOGS. WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY. INCLUDING BUT NOT LIMITED TO. PERMANENT DISABILITY, SICKNESS OR DEATH TO THE HUMAN OR DOG. AND (B) THERE MAY BE OTHER RISKS NOT KNOWN TO YOU OR

WAGMORE, NOR READILY FORESEEABLE AT THIS TIME (COLLECTIVELY "RISKS"). YOU FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS INCLUDING WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF YOUR DOG'S PARTICIPATION AT WAGMORE, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BELHALF OF OR CAUSED BY YOUR DOG. "SICKNESS" INCLUDES ANY ILLNESS NOT LIMITED TO BORDETELLA (KENNEL COUGH), BLOAT, OR ANY OTHER FORM OF CONTAGIOUS DISEASE.

Veterinarian Liability and Care. Wagmore will have the right to obtain medical treatment for your dog, if, in Wagmore's sole discretion, it appears that your dog may be ill, injured or exhibits any other behavior that would reasonably suggest that your dog may need medical treatment. YOU WILL BE FULLY RESPONSIBLE FOR ALL COSTS RELATED TO ANY MEDICAL TREATMENT, INCLUDING WITHOUT LIMITATION, THE COST OF ANY TRANSPORTATION FOR THE PURPOSE OF SUCH TREATMENT. You must also provide veterinary records to Wagmore upon request.

Waiver, release, and indemnification. You hereby agree to expressly and forever generally waive, discharge claims, indemnify, release from liability, save, hold harmless and defend Wagmore, their invitees, owners, officers, directors, employees, contractors, volunteers, agents, representatives, lessors, and all others having an interest in Wagmore from and against any and all injury, liability, claims, litigation, actions, suits, costs, losses, damages, attorney's fees, expenses or demands of every character whatsoever on account of, arising out of, resulting from or relating in any way to (i) any act or omission of the Releases (ii) your dog's participation at Wagmore. YOU AGREE THAT THIS RELEASE IS BINDING ON YOU AND OUR SUCCESSORS, HEIRS LEGAL REPRESENTATIVES AND ASSIGNS. YOU ALSO EXPRESSLY AND FOREVER RELEASE WAGMORE FROM ANY DUTY TO PROTECT YOU OR YOUR CAMPER FROM INJURY OF ANY KIND AND AGREE THAT ANY IMPLEMENTATION OF SAFETY PRECAUTIONS BY WAGMORE WILL NOT WAIVE WAGMORE'S RIGHT TO BE INDEMNIFIED AS PROVIDED HEREUNDER, AND SUCH PRECAUTIONS WILL NOT ALTER THIS RELEASE.
